Official Rules**

1. SWEEPSTAKES PERIOD: The Blakeney Town Center Mother's Day Giveaway Sweepstakes (the "Sweepstakes") will begin at 12:00 a.m. E.T. on Wednesday, May 1, 2024 and end at 11:59 p.m. E.T. on Sunday, May 12, 2024 ("Sweepstakes Period").
